

Adaptive Business Management Systems Privacy Policy

Updated policy: Effective on April 04, 2020

This privacy statement describes how Adaptive Business Management Systems collects and uses the personal information you provide on our Websites: adaptivebms.com, adaptivebms.co.uk, adaptivebms.net, and any other domains owned by Adaptive Business Management Systems Ltd . It also describes the choices available to you regarding our use of your personal information and how you can access and update this information.

Adaptive Business Management Systems complies with the EU Safe Harbor framework as set forth by the Department of Commerce regarding the collection, use, and retention of data from the European Union

Collection and Use of Personal Information

We collect the following personal information from you

- Contact Information such as name, email address, mailing address, phone number
- Unique Identifiers such as user name, account number, password

As is true of most Web sites, we automatically gather information about your computer such as your IP address, browser type, referring/exit pages, and operating system.

When we collect information by means of you voluntarily submitting it to us, we will notify you as to why we are asking for it and how it will be used. Set out in this Policy are some of the circumstances when we might collect personal data and what it may be used for.

We require customers who register to use the services offered on our Site (collectively, the “Service”) to give us an email address.

We use this information to

- Fulfil your order
- Send you an order confirmation
- Assess the needs of your business to determine suitable products
- Send you requested product or service information
- Send product updates or warranty information
- Respond to customer service requests
- Administer your account

- Respond to your questions and concerns

This Policy applies only to personal information that we collect from you. We provide a service from our web site that permits users to share information with each other by creating, uploading, and attaching information to shared "tasks" that are stored on our website. This Policy does not apply to personal information that you share with other users when you submit or upload it to these shared tasks. Instead, our use and distribution of information submitted to tasks is described in our Terms of service and Subscriber agreement.

Choice/Opt-Out

Customers can opt-out of being contacted by us, or receiving such information from us, by following the opt-out instructions located in the e-mails we may send you, by changing your privacy settings in the Service, or by contacting us at any time.

Adaptive Business Management Systems reserves the right to send its existing customers certain communications relating to the Service as part of our commercial relationships with you, such as service announcements and administrative messages without offering the opportunity to opt-out of receiving them. If you do not wish to receive them, you have the option to cancel your account by contacting Adaptive Business Management Systems Ltd and requesting account cancellation.

Testimonials

Information Sharing

Except as we explicitly state at the time we request information we do not disclose to third parties the information provided. We do not sell your personal information to third parties.

Adaptive Business Management Systems uses a third-party intermediary to manage the credit card processing. This intermediary is solely a link in the distribution chain and is not permitted to store, retain, or use the information provided, except for the sole purpose of credit card processing. Other third parties, such as content providers, may provide content on the Site but they are not permitted to collect any information nor does Adaptive Business Management Systems share user information with these parties.

Customers of the Service will be using the Site to host data and information ("Data"). Adaptive

Individual records may at times be viewed or accessed for the purpose of resolving a problem, support issue, or suspected violation of the Master Subscription Agreement, or as may be required by law. Of course, customers are responsible for maintaining the confidentiality and security of their user registration and password.

Third-Party E-Commerce Solutions Provider

Our shopping cart is hosted by our e-commerce solutions provider. They host our ordering system and collect your billing information directly from you for the purpose of processing your order. This company does not use this information for any other purpose.

Cookies and Other Tracking Technologies

We use a number of different cookies on our site. If you do not know what cookies are, or how to control or delete them, then we recommend you visit <http://www.aboutcookies.org> for detailed guidance.

The list below describe the cookies we use on this site and what we use them for. Currently, we operate an ‘implied consent’ policy which means that we assume you are happy with this usage. FIRST PARTY COOKIES

These are cookies that are set by this website directly.

Google Analytics: We use Google Analytics to collect information about visitor behaviour on our website. Google Analytics stores information about what pages you visit, how long you are on the site, how you got here and what you click on. This Analytics data is collected via a JavaScript tag in the pages of our site and is not tied to personally identifiable information. We, therefore, do not collect or store your personal information (e.g. your name or address) so this information cannot be used to identify who you are.

THIRD-PARTY COOKIES

These are cookies set on your machine by external websites whose services are used on this site.
